The office is located approximately 5 minutes from Palisades Interstate Parkway (PIP), less than 30 minutes from the George Washington Bridge (GWB) and less than 15 minutes from the Tappan Zee Bridge (TZB).

From Manhattan or points South via the Palisades Interstate Parkway (PIP):

George Washington Bridge upper level (easiest) to PIP (1st exit after the bridge). PIP to Exit 10/New City to traffic light. Left at light onto Germonds Rd to next intersection (South Little Tor Rd). Right onto South Little Tor Rd and go 3 lights to Collyer Ave. Turn Right onto Collyer Ave and continue for ½ mile to end = intersection of South Main St. (Higgins Funeral Home on Left). Right onto South Main St. Go approx 100 ft. & through next intersection (Laurel Rd.). Building is just after this intersection on Left. Enter at the 2nd driveway. See NOTE* below.

Via Garden State Parkway (GSP):

North on GSP to the end. Continue to exit for Nanuet/bear left towards signs to Tappan Zee Bridge -this puts you on the NY State Thruway going East (87). Exit 13N to Palisades Interstate Parkway North. PIP to Exit 10/New City to traffic light. Left at light onto Germonds Rd to next intersection (South Little Tor Rd). Right onto South Little Tor Rd and go 3 lights to Collyer Ave. Turn Right onto Collyer Ave and continue on Collyer for ½ mile to end = intersection of South Main St. (Higgins Funeral Home on Left). Right onto South Main St. Go approx 100 ft. & through next intersection (Laurel Rd.). Building is just after this intersection on Left. Enter at the 2nd driveway. See NOTE* below.

Via Tappan Zee Bridge:

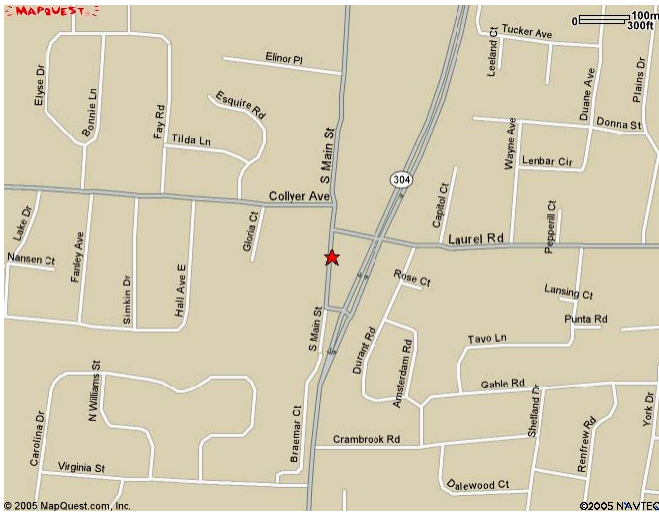
West on Thruway to exit 13N (PIP) North towards Bear Mountain. PIP to Exit 10/New City to traffic light. Left at light onto Germonds Rd to next intersection (South Little Tor Rd). Right onto South Little Tor Rd and go 3 lights to Collyer Ave. Turn Right onto Collyer Ave and continue on Collyer for ½ mile to end = intersection of South Main St. (Higgins Funeral Home on Left). Right onto South Main St. Go approx 100 ft. & through next intersection (Laurel Rd.). Building is just after this intersection on Left. Enter at the 2nd driveway. See NOTE* below.

Via Palisades Interstate Parkway (PIP) from points north

PIP Exit 11/New Hempstead-New City. Exit to traffic light (intersection =New Hempstead Rd./Co. Rd. 80). Go left toward "New City/Government Offices". Continue on New Hempstead Rd., down large hill to 3rd light = So. Little Tor Rd./Co. Rd. (route 33 South). Right onto So. Little Tor. Continue for 0.7 miles to 1st light =Collyer Ave. Left onto Collyer. Continue on Collyer Ave. ½ mile to end = intersection of So. Main Street. (Higgins Funeral Home on Left). Right onto So. Main Street. Go ~100 ft. & through next intersection (Laurel Rd.). Building is just after this intersection on Left. Enter at the 2nd driveway. See NOTE* below.

From Nanuet/Pearl River/Northern Bergen Co. via Kinderkamack Rd/Rte 304 traveling North: Drive through Nanuet and Bardonia. Pass traffic light at Leona Ave. In approx ¼ mile, look for sign for "*New City Business District*" follow this *Left* turn from Route 304 onto South Main Street. (The building is at the 304/South Main Street junction). Turn Right into the first driveway on the Right. (If you miss this left turn, note you cannot turn Left onto Laurel Rd. from Rte. 304 North. If you miss the turn, go left at the next light –Third St., Left onto Main to #350 on left after Laurel Rd)

NOTE*: Building sign reads: "Premier Orthopedics" The office building is easy to find -it is a modern, white, one-story building on pillars. Parking available in the surrounding lot. Enter through glass doors in the center on the ground level. Take elevator or walk up the one flight to lobby area. Walk past large reception desk, through double doors. Turn left down hall to end. Our staff will greet you, there.
