## Alan DeForest Smith Memorial Lecturer



### John M Flynn, MD

John M. “Jack” Flynn, MD, completed his surgical training at the Harvard Combined Orthopaedic Surgery Program, followed by a pediatric orthopedic fellowship at A.I. DuPont Hospital for Children, Wilmington, DE. He is Chief of the Division of Orthopaedics at Children’s Hospital of Philadelphia (CHOP).

A nationally recognized orthopedic leader, Dr. Flynn’s primary clinical and research focus is scoliosis care for children and teens.

Dr. Flynn pioneered the use of image-guided navigation for pediatric spinal deformity correction—significantly improving the safety of implant placement. He has collaborated with CHOP experts in anesthesia, pain management and post-operative nursing and therapy to develop the famous CHOP Scoliosis Rapid Recovery Pathway (RRP). Since publishing the results of the CHOP RRP, many other centers across the country have adopted similar care standards. Dr. Flynn is also a recognized leader in non-operative care for pediatric spine deformities. He helped establish CHOP’s Schroth physiotherapy scoliosis-specific exercise (PSSE) program and led CHOP’s effort in the landmark National Institutes of Health BRAIST trial which conclusively proved the efficacy of back bracing as a treatment for scoliosis. He is a member of several international multi-center scoliosis research networks, including the Harms Study Group, and the Growing Spine Study Group. He has been President of the Children’s Spine Study Group run by the Children’s Spine Foundation.

Dr. Flynn’s has served as President of the Pediatric Orthopaedic Society of North America, President of the Children’s Spine Study Group, Research Committee Chair of the Scoliosis Research Society. He is currently serving a 10-year term as a Senior Director of the American Board of Orthopaedic Surgery. Dr. Flynn has published more than 250 peer-reviewed scientific articles, reviews, and textbook chapters. He is editor of three principal texts in pediatric orthopaedic surgery: Lovell and Winter’s *Pediatric Orthopaedics*; Rockwood and Wilkins’ *Fractures in Children*; and *Operative Techniques in Orthopaedic Surgery*.

Dr. Flynn has lectured as a Visiting Professor at more than 60 academic centers nationally and internationally, speaking on improving quality, safety, and value in pediatric spine deformity, optimizing care of pediatric fractures, and work-life integration and wellness for surgeons and physicians.

*The Alan DeForest Smith Memorial Lecture was established in honor of an orthopedic surgeon who dedicated his career to the achievement of excellence in medical education and patient care. Dr. Smith joined NYOH in 1921 and was a protege of Dr. Russell Hibbs. Dr. Smith directed the New York Orthopaedic Hospital from 1940 to 1956, a time of critical transition for the Hospital. It was during these years that NYOH joined the family of hospitals then known as Columbia-Presbyterian Medical Center. Dr. Frank E. Stinchfield, Dr. Smith’s successor, initiated the tradition whereby the Alan DeForest Smith Memorial Lecture is given at the New York Orthopaedic Hospital Alumni Association meetings by a visiting professor prominent in the field of orthopedic surgery.*

### Charles L. Nelson, MD

Charles L. Nelson, MD, is the Chief of Adult Reconstruction and a Professor of Orthopaedic Surgery at the University of Pennsylvania Perelman School of Medicine

Dr. Nelson graduated from Rensselaer Polytechnic Institute and the University of Pennsylvania Medical School, where he completed his internship and residency. After finishing a fellowship in adult reconstructive surgery at the Hospital for Special Surgery, he returned to the University of Pennsylvania where he is currently a Professor of Orthopaedic Surgery and Chief of Adult Reconstruction. He was an AAOS Leadership Fellow from 2004-2005 and represented the American Orthopaedic Association as an Austrian Swiss German Traveling Fellow in 2012. He has received numerous awards – he was one of two nationally chosen recipients of the National Medical Fellowship's James H. Robinson, MD Memorial Scholarship for outstanding achievement in the study of surgery in addition to winning the Helen O. Dickens, MD Award, the Charles Drew Award and William T Fitz, Jr. Awards at the University of Pennsylvania. School of Medicine.

Dr. Nelson has served in volunteer and leadership positions in various medical, fraternal and charitable organizations. He is currently on the Board of Directors for the American Board of Orthopaedic Surgeons (ABOS), where he Chairs the Credentials Committee and the Diversity, Equity and Inclusion Committee. He is a Past-President of the J. Robert Gladden Orthopaedic Society (JRGOS). He is a member of the membership committee of the Hip Society, and the Inaugural Co-Chair of the newly formed combined Hip Society and Knee Society Diversity, Equity and Inclusion Committee. He has previously served on the Board of Directors for The Knee Society as well as several committees and advisory boards for the AAOS, AAHKS, and AOA. He is the Deputy Editor for Adult Hip and Knee Reconstruction for the Journal of the American Academy of Orthopaedic Surgeons and is the current Chair for the American Orthopaedic Associations "Emerging Leaders Forum." Dr. Nelson has been named as a "Top Doc" by *Philadelphia Magazine* and *Philadelphia Life Magazine* on several occasions and has been selected several times to be among the Top Physicians and Surgeons in America by both peers and consumers including Best Doctors, Inc., Castle and Connely, and the Consumer's Research Council of America. He has published more than 100 peer review manuscripts, as well as several dozen book chapters. He has been a co-investigator or site principal investigator on both federally sponsored and industry sponsored grants.

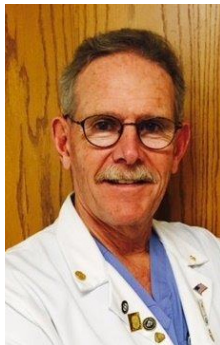
*Chairman and Director of the New York Orthopaedic Hospital from 1956 to 1976, Dr. Frank E. Stinchfield guided NYOH into the future of orthopedic surgery. He reformed residency education, established a program in orthopedic research, introduced subspecialty clinics to improve patient care, and both led and inspired the development and implementation of innovative surgical technique. To honor and commemorate the 48 years of distinguished service and leadership given by this visionary surgeon, researcher, administrator, and educator, the Alumni in 1993 voted to establish the Frank E. Stinchfield Memorial Lecture. Beginning in 1995, the lecture is to be given at each biennial meeting of the NYOH Alumni Association by a visiting professor prominent in the field of orthopedic surgery.*

## Distinguished Alumnus Award



### William H. Seitz, Jr., MD

William H. Seitz, Jr., MD, joined the Cleveland Clinic Beachwood Family Health and Surgery Center as a hand and upper extremity surgeon. He also serves as the Executive Director of the Cleveland Orthopaedic and Spine Hospital at Lutheran Hospital and Director of Hand and Upper Extremity.

Dr. Seitz is a fellow of the American Academy of Orthopaedic Surgeons, a founding member of the International Society for Fracture Repair and a member of the American Shoulder and Elbow Surgeons Society. He most recently served as the Chairman for the American Society for Surgery of the Hand's (ASSH) 3rd Combined Meeting of the Japanese and American Societies for Surgery of the Hand.

He was named to Who's Who in Medicine and Healthcare and Science and Engineering (1997-2000) and in Woodward and White's *The Best Doctors in America, Midwest Region Edition* (1996-2000). In 1992-1993 was named the Sterling Bunnell International Traveling Fellow for the ASSH.

Dr. Seitz's specialty interests include management of problems of the entire upper extremity, including the shoulder, elbow, wrist, and hand arising from congenital, arthritic, traumatic, neurologic, and acquired conditions. He has been visiting professor and keynote speaker nationally and internationally on his work in shoulder, elbow, wrist, and hand problems.

*The Distinguished Alumni Award is given to the alumnus who has made a major contribution to orthopedic surgery in the fields of teaching, research, and patient care and who has established both a national and international reputation in his or her field of interest. The first Distinguished Alumni Award was presented in 1995.*

## Louis U. Bigliani Lecture

*In recognition of his distinguished career and impact on the field of shoulder surgery, the Louis U. Bigliani Lectureship was established and endowed by the members of the Columbia Shoulder Society in 2018. Protégé to Dr. Charles S. Neer II, the father of modern shoulder surgery, Dr. Louis Bigliani spent his entire career at NYOH/Columbia, eventually serving as the 9th Director of the New York Orthopaedic Hospital and Chair of Columbia University's Department of Orthopedic Surgery from 1998 - 2014. Beginning in 2018, the lecture is to be given at each biennial meeting of the NYOH Alumni Association by a visiting professor prominent in the field of shoulder surgery.*

### Gerald R. Williams, MD

Dr. Williams is The John M. Fenlin, Jr Professor of Shoulder and Elbow Surgery at The Sidney Kimmel Medical College of Thomas Jefferson University. As a member of the Division of Shoulder and Elbow Surgery at the Rothman Institute, his practice is limited to the diagnosis and management of shoulder disorders, with extensive experience in the field of shoulder replacement. He currently serves as a member of the AAOS Strategic Planning Committee, and as a member of the Rothman Institute Board of Directors. He is also co-Chief of Musculoskeletal Medicine at Main Line Health System in the Philadelphia area. He has previously served as the 2nd Vice President, 1st Vice President, President, and Past President of the American Academy of Orthopaedic Surgeons, President of the American Shoulder and Elbow Surgeons, President of the Pennsylvania Orthopaedic Society, and President of the Philadelphia Orthopaedic Society. Although he was born in Ft. Myers, Florida, Dr. Williams grew up in West Chester, Pennsylvania, graduating with honors from Henderson High School, with honors from Ursinus College, and with honors from Temple University School of Medicine. He completed his internship and residency in Orthopaedic Surgery, and Fellowship training in shoulder surgery (1984, 1990) at the University of Texas Health Science Center in San Antonio. He was in solo private practice for 1 year (1990–1991) at Graduate Hospital, full time academic practice at the University of Pennsylvania for 16 years (1991–2007) and private practice at the Rothman Institute and Thomas Jefferson University Health System for 13 years (2007–present). Dr. Williams' teaching and research experience is extensive. He has participated as a faculty member or organized over 250 educational meetings, authored approximately 200 scientific articles and 45 review articles or book chapters, and co-edited four textbooks on shoulder surgery. In addition, he has been involved in product design in the shoulder arthroplasty space for over 20 years. He is an inventor on approximately 15 patents. ## Marvin Shelton Invited Lectureship in Orthopaedic Trauma



### Marcus F. Sciadini, MD

Dr. Marcus Sciadini is the Professor of Orthopaedic Surgery at the University of Maryland School of Medicine Midtown Campus where he is Chief, Department of Orthopaedics.

In 1992, Dr. Sciadini graduated from the Vanderbilt University School of Medicine on the Justin Potter Medical Scholarship. He completed a general surgery internship at Vanderbilt in 1993 and an orthopaedic research fellowship in 1995. He then went on to complete his orthopaedic residency at Vanderbilt in 1999 followed by an orthopaedic trauma fellowship at the R. Adams Cowley Shock Trauma Center at the University of Maryland in 2000 where he primarily practices today.

Dr. Sciadini led the University of Maryland Haitian Earthquake Relief Mission in 2010 supervising the triage of injured patients. He has authored over 100 peer reviewed publications in the field of orthopaedic trauma and book chapters on complex injuries. He serves at the local level on many Shock Trauma committees as well as the Orthopaedic Trauma Association Membership Committee and the Foundation for Orthopedic Trauma Research Committee at the national level. He is a consultant reviewer for the *Journal of Orthopaedic Trauma*, *Journal of the American Academy of Orthopaedic Surgeons*, and *Clinical Orthopaedics and Related Research*.

Dr. Sciadini is the first Marvin L. Shelton, MD, lecturer to have a direct relationship with Columbia residents who rotate at Shock Trauma. His mentorship to the Columbia Orthopaedic Residency has helped shape many of our residents who have chosen the field of orthopaedic trauma.

When not working, Dr. Sciadini enjoys time with his wife and two daughters and keeps active with CrossFit, mountain biking, and wakeboarding.



The Marvin L. Shelton MD Memorial Lectureship in Trauma honors Dr. Shelton's commitment to the advancement of trauma surgery.

During his 40 years at Columbia, Dr. Shelton was a key contributor to the history and foundation of the Department of Orthopedic Surgery at Columbia University Irving Medical Center (CUIMC). Recruited by Dr. Frank E. Stinchfield in 1968, Dr. Shelton became the first African American attending orthopedic surgeon at CUIMC, as well as the first Black orthopedic surgeon to gain admitting privileges at any Ivy League institution.

As an attending surgeon, Dr. Shelton spent much of his time treating trauma patients and innovating implants for ankle and lower extremity fractures. His work led him to create the Neer-Grantham-Shelton Plate, a contoured plate and screw system for femur supracondylar fractures, and the contoured plate system for fractures of the distal fibula. Dr. Shelton pioneered advances in orthopedic surgery as well, including the surgical technique of Trimalleolar Dislocations.

Beginning in 2005, the lecture was previously given at an annual trauma course in NY before moving to the biennial meeting of the NYOH Alumni Association in 2023. The lecture is given by a visiting professor prominent in the field of orthopedic trauma.
